ARIZONA DEPARTMENT OF HOUSING

By Channel 12 News

ADOH Programs Administrator Kathy Blodgett shared with 12 News (KPNX-TV, NBC) viewers how individuals can access federal ADOH weatherization funding to create a more energy-efficient home. To find the provider for your

area in Arizona, visit **bit.ly/3JC5hK3**, apply, and, if the household is income-eligible, they will be able to schedule a personal in-home audit.

With the additional \$47.5 million in Federal weatherization funding, ADOH will be able to help make more than 3400 Arizona homes more energy efficient. The funding can be used for new HVAC systems, insulation, duct work, appliances, sealing and more. Learn more about how you can receive this weatherization funding on ADOHr website: housing.az.gov.



The federal programs can help save the average working family up to \$1,000/year on energy bills. \$9 billion is available in consumer rebates to help low-income families switch to electric appliances and afford the cost of energy-saving home retrofits.

Among the events highlighted were consumer energy-saving programs in two Biden Administration Acts, ADOH is discussing the expansion of the Weatherization Assistance Program. ADOH Director **Joan Serviss**, announced that ADOH WAP received an additional \$47.5 million to deliver economic and consumer benefits directly to Arizona communities.

This is the first ADOH-funded project to utilize Arizona's new STATE tax credits and will bring 368 new affordable homes to the West Valley! https://lnkd.in/gvfRrrNC

ADOH Deputy Director Ruby Dhillon-Williams and staff attended the Urban Land Institute 'Trends' Day at the J.W. Marriott Phoenix Desert Ridge Resort & Spa in Phoenix. The annual event brings together more than 1000 real estate, land use, and government housing experts to shape the future of housing. This year, the conference is taking a deep dive into the various solutions to the affordable/supportive housing crisis in Arizona.

Mary Lou Rosales, Executive Director for Community Action Human Resources Agency is a recipient of these funds and is looking forward to expand the program in Pinal County. Anytime we can do more for the most vulnerable, especially limited income homeowners, we are so pleased to take the opportunity and help them save on energy bills. DES CHILD CARE ASSISTANCE

Did you know child care assistance is available for parents who are full-time students?

The Division of Child Care offers child care assistance for:

- Low-income working families
- Teen parents enrolled in high school, GED, ESOL, or remedial education programs
- Residents of homeless or domestic violence shelters
- Individuals who are unable to care for their children due to a physical, mental or emotional condition
- Individuals who are unavailable to care for their children due to participation in court-ordered community service or participation in a drug treatment program
- Individuals who are currently receiving full-time DES child care assistance who enroll in a fulltime education or employment training program, and submit a work requirement waiver to DES, including proof of enrollment

Child care assistance is also available for grandparents and guardians:

- When the parent of the child is not living in the same home
- When the grandparent or guardian is engaged in an eligible activity
- Note: Only income received on behalf of the child is considered.

Child care assistance is available without regard to income for the following:

- DES Cash Assistance recipients
- Grant Diversion program for job search
- TANF recipients who are employed
- Referrals from a DES Jobs Program
- Referrals from the Arizona Department of Child Safety or Tribal Child Welfare program

Student parents attending school at a DES Higher Education Child Care Project (HECCP) community college or university may be eligible for child care assistance through one of these participating HECCP institutions:

- Arizona State University(link is external)

- Central Arizona College(link is external)
- Maricopa Community Colleges(link is external)
- (link is external)
- Northern Arizona University(link is external)
- Pima Community College(link is external)

SOCIAL SECURITY COLUMN

HOW WE PROTECT YOU FROM MISLEADING ADVERTISING AND COMMUNICATIONS



Social Security works with the Office of the Inspector General (OIG) to protect you from scams that use Social Security as bait. **Section 1140 of the Social Security Act** allows OIG to impose severe penalties against anyone who engages in misleading Social Security-related advertising or imposter communications. You can review Section 1140 at www.ssa.gov/OP Home/ssact/title11/1140.htm.

For example, the OIG may impose a penalty against anyone who:

- Mails misleading solicitations that appear to be from or authorized by Social Security.
- Operates an imposter internet website or social media account designed to look like it belongs to or is authorized by Social Security.
- Sends emails or text messages or makes telephone calls claiming to be from Social Security.
- Sells Social Security's free forms, applications, and publications without our written approval.
- Charges a fee for a service that Social Security provides
 free of charge without providing a clearly visible notice
 that Social Security provides the service for free.

If you receive a misleading or suspicious Social Securityrelated advertisement or imposter communication, please let us know immediately. Try to capture as much information about the communication as you can.

Here's what you can do:

- For suspicious websites or social media accounts, please take a screenshot of the page. Please note the website
 address or social media link and how you came across it.
- For emails and text messages, please capture the entire message and any message links.
- For U.S. mail solicitations, please retain the complete communication, including the outside envelope and all inserts.
- For telephone solicitations, please note the caller identification phone number and any company name or call back number that the caller or recorded message provides.

You can help us stop misleading advertising and communications. We encourage you to report potential scams to the OIG at oig.ssa.gov. You can also call our fraud hotline at 1-800-269-0271 or send an email to OIG.1140@ssa.gov.

This information will help OIG locate the source of the suspicious solicitation or communication. You can also check out our publication, What You Need to Know About Misleading Advertising, at www.ssa.gov/pubs/EN-05-10005.pdf.

Your *Statement* is an easy-to-read summary of the estimated benefits you and your family could receive, including potential retirement, disability, and survivors' benefits.

Our Plan for Retirement tool in your personal *my* Social Security account allows you to check various benefit estimate scenarios. You can compare how different future earnings and retirement benefit start-dates might affect your future benefit amount.

Please tell your friends and family about the steps they can take to improve their financial knowledge by exploring their personal *my* Social Security account. If they don't have an account, they can easily create one at www.ssa.gov/myaccount.

STATEMENT BY KILOLO KIJAKAZI, ACTING COMMISSIONER OF SOCIAL SECURITY, ON THE PRESIDENT'S FISCAL YEAR 2024 BUDGET

The Biden-Harris Administration today released the President's Budget for Fiscal Year 2024. The Budget details a blueprint to grow the economy from the bottom up and middle out, lower costs for families, protect and strengthen Medicare and Social Security, and reduce the deficit by ensuring the wealthy and big corporations pay their fair share—all while ensuring no one making less than \$400,000 per year pays more in taxes.

"Our programs affect individuals throughout their lives: from birth, to entering the workforce, to facing a disability or loss, and to retirement. The broad and critical nature of our programs drives our request for the resources necessary to improve our service to the public."

The President's FY 2024 Budget request for the Social Security Administration (SSA) proposes \$15.5 billion in discretionary budget authority. The Budget will:

- Improve Service Delivery: The Budget provides an increase of \$1.4 billion, a 10-percent increase over our FY 2023 enacted level to improve customer service at our field offices, State disability determination services, and teleservice centers for retirees, people with disabilities, and their families while maintaining the integrity of our programs. Each year, we process more than 6 million retirement, survivors, and Medicare claims and more than 2 million disability and SSI claims. The Budget supports increased staffing levels from FY 2023, allowing us to process about a half million more disability cases in FY 2024 than we completed in FY 2022 and significantly reduce wait times for those decisions.
- Advance Equity and Accessibility: We are one of the most important anti-poverty programs in the country. We remain committed to administering our programs in a way that promotes equity and fairness. We are making it easier for people to access the services they rely on, including individuals experiencing homelessness, children with disabilities, and people with mental and intellectual disabilities. The Budget makes investments in these areas to support SSI outreach work, including collaborating with government agencies and other third-party organizations in local communities to provide convenient access to our services and ensure members of the public are aware of their potential benefit eligibility.
- We are also committed to enhancing the diversity and richness of our workforce to strengthen and maintain an inclusive work environment that values individual differences and treats employees with dignity and respect; thereby, enriching our current workforce, which is driven by our public service mission. This Budget continues our efforts to hire and promote the Nation's best talent and build a diverse and representative workforce and ensure that all employees have equal opportunities to advance in their chosen careers.

- Modernize our Information Technology: The Budget continues investment in our information technology (IT) to reduce the burden on the public, modernize our website and online services, and provide an improved customer experience.
- To accelerate our progress, the Budget includes \$50 million in dedicated no-year funding for our Benefits Modernization efforts. Our Benefits Modernization efforts will provide our employees with better technology tools to determine eligibility and process claims in order to better serve the public. The Benefits Modernization project is in addition to the efforts we are taking to sustain our systems.
- Provides National, Comprehensive Paid Family and Medical Leave: The vast majority of America's workers do not have access to paid family leave, including three out of four private sector workers. Among the lowest-paid workers, who are predominantly women and workers of color, 92 percent have no access to paid family leave through their employers. As many as one in five retirees leave the workforce earlier than planned to care for an ill family member, which negatively impacts families as well as the Nation's labor supply and productivity. The Budget proposes to establish a national, comprehensive paid family and medical leave program administered by SSA. The program would: provide workers with progressive, partial wage replacement to take time off for family and medical reasons; include robust administrative funding; and use an inclusive family definition. The Budget would provide up to 12 weeks of leave to allow eligible workers to take time off to: care for and bond with a new child; care for a seriously ill loved one; heal from their own serious illness; address circumstances arising from a loved one's military deployment; or find safety from domestic violence, sexual assault, or stalking. The Budget would also provide up to three days to grieve the death of a loved one. The Administration looks forward to continuing to work with the Congress to make this critical investment and strengthen America's economy.

Building on the President's strong record of fiscal responsibility, the Budget more than fully pays for its investments—reducing deficits by nearly \$3 trillion over the next decade by asking the wealthy and big corporations to pay their fair share.
