- 10. Affordable Housing and Reentry Round Table Updates
 - SAVE THE DATE September 28, 2023 from 8:30-12:30. A Save the date will be emailed with instructions on how to register. Molina Healthcare and Habitat for Humanity Flagstaff are speakers. No update on the Reentry Roundtable. Arizona Town Hall will be supporting the roundtable.
- 11. Committee report outs facilitated by the Chair (3 min. each max.)
 - a. Statewide CoC Governance Advisory Board Maria-Elena Ochoa HMIS and ACCCHS have joint data sharing agreements. State schools have also executed a dat sharing agreement with HMIS and ACCCHS to share alternative ways to measure acuity. HUD is releasing new data standards. The 2023 NOFO is out. The Gab will be reviewing the method to score bonus projects. There is a set-aside for domestic violence.
 - b. State LCEH Leads Meeting Maria-Elena Ochoa ADOH is waiting for the HUD agreement before sending out the planning grant agreements. ADOH is trying to identify all access points. ADOH will be applying for the 2023 NOFO. DV is a priority and rural county capacity building funding is available. ADOH is seeking letters from Coalitions and persons with lived experience. PHAs should be involved in CE and seeking a set-aside for persons experiencing homelessness. Bonus project application has been released.

- c. PIT Committee Suzanne Payan Received 2023 preliminary data. Total 165 households and 219 persons. This number is down from what was submitted due to incomplete surveys.

 HUD has new data requirements. Training will be coming out. The BoS will be holding statewide meetings this fall.
