Yesterday, the U.S. Department of Housing and Urban Development (HUD) officially withdrew the FY 2025 Continuum of Care Notice of Funding Opportunity (NOFO). This decision was made to allow HUD to make appropriate revisions and incorporate new priorities into the NOFO. HUD has stated its intent to reissue a modified NOFO well ahead of the deadline for obligating FY 2025 funds. In the meantime, we should be prepared to resume activity as soon as the revised NOFO is released. Currently this new NOFO focuses on transitional housing projects with treatment requirements, Support Services Outreach, and limits renewal PH projects to 30% of total renewal budget. PH projects are able to consider transitional grant status to transition to a transitional Housing project with a 2 year limitation and mandatory treatment if they meet all the requirements. What will exactly change with this withdrawal we do not know, but this does allow agencies to look at completing applications if they needed more time that will be easier to tweak with whatever changes are decided on.

PCCEH invited non-profit member agencies to submit proposals for pilot programs aimed at strengthening capacity to serve individuals and families experiencing housing crises. These programs focus on priority service areas including case management, treatment, housing, discharge, outreach, and support services. The funding period is January 1 through June 30, 2026, with contracts executed by January 7, and multiple awards may be granted. Eligible programs must be new or expanded services, encourage evening and weekend availability, and meet reporting and HMIS requirements to demonstrate effectiveness and improve coordinated entry. I'm pleased to share that we received applications from two agencies: HOHP and CGA. We will contact them to discuss how we will move forward.
